1. Housekeeping

- TK opened the meeting by welcoming everyone and introduced new members: the recently elected ACC President, Prashant Kushwaha and the Chair of the Athletes Committee, Sebastian Brendel.
- TK highlighted to the members that this meeting will focus on the presentation of the organisational review and presentation and voting on the Canoe Slalom and Paracanoe qualification systems for the 2028 Olympic Games in Los Angeles.

2. Quorum

- A quorum was formed in line with the ICF Statutes, with 30 Board Members present.

3. ICF President Welcome

- TK announced that the Sprint Qualification System was approved by the IOC Executive Committee on 10 December 2025, with only minor wording changes, reflecting the dedicated efforts of all working group members.

4. Canoe Slalom Olympic Qualification System, Los Angeles 2028

RF presented the Canoe Slalom Olympic Qualification System for Los Angeles 2028.

Decision: The BoD voted unanimously in favour to submit the Canoe Slalom Olympic Qualification System for Los Angeles 2028 to the International Olympic Committee (IOC).

5. Para Canoe Paralympic Qualification System, Los Angeles 2028

JE presented six recommendations for the LA 2028 Para Canoe Qualification System:

- JZ expressed concerns about the tight calendar for the European Continental Championships, stressing the need for events before the end of May.
- JE and the Board agreed that, pending IPC approval, continents may discuss and determine dates that align with the qualification framework.

Decision: The BoD voted unanimously in favour to submit the Paracanoe Paralympic Qualification System for Los Angeles 2028 to the International Paralympic Committee (IPC).

6. Organisational Review

- TK reiterated that the purpose of this session was to inform the Board about outcomes from organisational review discussions, particularly structural and governance changes.
- No decisions were to be made; instead, comments, suggestions, and questions would be collected for detailed discussion at the next in-person Board meeting. He emphasised that it is now important to listen to all stakeholders also in two Town hall meetings with NF representatives and gather opinions before the board makes its final decision.



6.1 ICF Governance Structure (Group 5)

Mike Chamber (MC), appointed chair of Group 5, presented the proposed new governance model, shifting from a vertical structure to a horizontal, more agile and modern framework with:

- Executive Committee
- Council
- Sport Board
- Athletes' Board
- Continental Board
- Development Board

- The Congress remains the supreme authority, electing key leadership positions.
- Responsibilities and composition of all bodies (Executive Committee, Council, Boards, Medical & Anti-Doping Commission, Finance/Audit/Risk Commission, Technical Committees, Integrity Unit) were outlined.

Comments from the BoD:

- CF requested that all questions and comments be compiled and shared before town hall meetings (These will be scheduled before the first Board Meeting in 2026 and are to engage with all NFs to present the Organisational Review). She noted the importance of allowing significant structural changes when necessary and the importance of the experience and opinions from within the group and canoeing community to be the main driver for the final proposal.
- JE suggested adding a preamble explaining the goals and rationale behind the restructuring. MC agreed and will be added.
- JZ emphasised the need to define the organisation's core pillars (national federations, continental federations, disciplines, community, infrastructure).
- He also asked for clarity on the political role of independent members (6), balance of power between continents and disciplines, and how collaboration will function in the new horizontal structure.

Next Steps:

- The online form for submitting comments, questions, and proposals will be sent by ICF staff on 15 December.
- Board members are invited to submit written comments and questions by 18 January.
- Town hall meetings will take place in advance of the first Board Meeting of 2026.
- All submissions will be compiled into a publicly accessible file to ensure transparency and facilitate meaningful discussion at the town halls and the next BoD meeting.

6.2. ICF Statutes, rules, and policies (Group 1)

Greg Smale (GS), appointed chair of Group 1 presented ICF Statutes, rules, and policies across 12 proposals.

- Simplifying competition rules into two levels:
 - Common Rules
 - Sport-Specific Rules (Eliminating Principle Rules)
- Requiring Congress approval for changes to Chapter 1 (Common Rules).

- Introducing a standardised online form for rule-change proposals.
- Reducing and clarifying the number of Congress types.
- Proposed removal of proxy voting, noting mixed opinions within the Board.
- Formalising Continental Associations' roles within the Statutes.
- Replacing free membership categories with the option for low-fee memberships.
- Creating a centralised Integrity Unit covering ethics, safeguarding, compliance, and disciplinary procedures.
- Filling gaps in policies such as anti-corruption, conflicts of interest, human rights, transgender guidelines, legacy planning, and emergency event protocols.
- Establishing which policies should be global and which may be continent-specific.

Comments from the BoD:

- CF noted that some continents (e.g., COPAC) already have clearly defined responsibilities and recommended reviewing existing documents.
- She highlighted the importance of strengthening safeguarding policies.
Clarified that sanctions must be assigned by the responsible group, not by individuals.
- TK asked whether policy unification was intended across continents.
- GS confirmed that some policies should be global while others may allow regional flexibility.

No objections were raised, and members recognised the extensive work involved. Further discussion will continue at the next Board meeting.

7. Next Meeting

- The next BoD meeting will take place in Baku, 11–15 March 2026.
- The draft agenda was presented.

8. Other Business

8.1. ECA Headquarters in Lausanne

TK proposed offering office space to the European Canoe Association (ECA) within the ICF office in Lausanne.

TK asked if any members objected to continuing discussions with ECA.

No objections were raised.

- A discussion followed on gender equity and continental representation in ITOs and athlete participation.
- ICF emphasised the urgency of achieving 50/50 gender balance, and the need for comprehensive long-term planning across ICF activities
- The Sports Commission will analyse participation data and present an improvement plan in Baku.

Decision: the BoD voted in favour of the 2026 ITOs Nominations.

Decision: The BoD voted in favour of the 2026 Canoe Polo Competition Rules Appendices.

8.5. ICF Medical and Anti-doping Committee Road Map

- JG presented the roadmap, detailing initiatives on athlete safety, medical standards, research, and guidance on sensitive topics.
- Work is underway to publish accessible health and well-being resources on the ICF website.
