1. Representation of Danielle Richards (NZL) – Canoe Ocean Racing

The BoD reviewed the proposal from the Athletes' Committee regarding the selection of the female non-Olympic disciplines representative.

Decision: 24 votes, 20 in favour of Danielle Richards to be member of the Athletes' Committee as female non-Olympic disciplines representative and 4 abstentions.

2. Representation of Charlie Brackpool (GBR) – Canoe Freestyle

The BoD reviewed the proposal from the Athletes' Committee regarding the selection of the male non-Olympic discipline representative.

Decision: 24 votes, 22 in favour of Charlie Brackpool to be member of the Athletes' Committee as male non-Olympic disciplines representative and 2 abstentions.
