#### Description

#### **Welcome by the ICF President and President Report**

President Perurena welcomed the BoD to Beijing and thanked the Chinese hosts for their generosity.

The ICF had held discussions with the IOC President, Thomas Bach, and left with the impression there were no problems with Canoeing and the Olympic Games at the moment, but that canoeing must always strive to stay ahead of the game.

There were still discussions to be had about venues for LA 2028 for both sprint and slalom, as there were challenges for both.

The ICF would like more quotas for canoe slalom. It was felt the focus had to be towards the IOC's requirement that they did not want IFs to develop new venues, and prefer to use the existing infrastructure. The impact for the ICF was to develop and consider maximum use of its Olympic venues.

The BoD discussed how to stay relevant and how to work with future Olympic hosts to promote existing and potential future Olympic disciplines (such as Extreme Slalom).

The next Youth Olympic Games in Senegal will provide challenges for the ICF because of a lack of suitable venues, but the ICF was working on alternatives.

## **Treasurer's report**

There was discussion about the donation provided by the Hungarian Federation and how the money was being spent. The BoD determined that any future bid that offered money to the ICF in return for hosting an ICF event must demonstrate clearly the benefit of the money directly to the athletes and/or the sport. Money given directly to the ICF (or its members) would not be allowed.

A request was made for the treasurer to provide a more detailed breakdown of some of the items in the accounts from 2017-2018 which were all duly answered.

There was discussion about the working arrangement the ICF has with its photographer, and if it was possible for disciplines to use their own photographers. A request was also made to have photographs provided to the national federations for free. Under the current agreement with the ICF Photographer the ICF was unable to provide photos for free to the NFs.

The IOC budget was guaranteed until 2028. One suggestion was that the ICF should purchase its own office, because rent in Lausanne was very expensive.

## **Update on ICF Headquarter activities**

Technical rule books would be available for all disciplines by the end of April

Stand Up Paddling court case was ongoing, with the ICF about to deliver its final argument to the Court of Arbitration for Sport in April. A hearing was expected in June or July 2019.

Interviews for the newly created ICF Development Manager position would take place at the ICF headquarters on April 9 and 10.

The ICF had made considerable process in the area of governance, and were expecting a major improvement in our overall ASOIF ranking by the end of the process.

# **Update on Stand Up Paddling**

China confirmed that they would host the SUP World Championships at the venue where the 2008 Beijing Olympic sailing competition took place.

There was a strong chance a beer brand would provide sponsorship. There would be 50,000 EUR of prize money available.

The SUP World Championships would be held from October 24 to 27, and all continental associations were urged to encourage their athletes to take part.

#### **Update on Dragonboat**

The ICF reached a compromised proposal in China. The IDBF Chinese member was willing to abandon their claim to be the sole responsible federation and work with the ICF and Chinese Canoe Association.

The ICF had been invited to be part of the Asian Games 2022 for dragonboat.

#### **Prevention of Harassments and Safeguarding**

The IOC wished to support the IFs who were working on a program called The Prevention of Harassment and Abuse in Sport. The IOC was expecting the ICF will produce:

1. A strong statement condemning all forms of harassment and abuse in

- 2. Athlete safeguarding policies to prevent and to have procedures in place once the damage already happened
- 3. To have educated safeguarding officers at the World Champs this year.
- 4. To produce informative flyers for distribution to the athletes

Cecilia proposed the creation of a working group which she will chair.

Tim Lodge: Athletes Co. Chair Don Mackenzie: Medical Co, Chair

Mario Santos: Lawyer

Danielle Woodward: representing the interests of women, considering that girls

and women are one of the most vulnerable groups.

The President approved the Team and they were officially invited to work. They all accepted the invitation.

## **Olympic Broadcast Service**

The ICF had met with the Olympic Broadcasting Service. Progress, albeit slow, was being made and they looked likely to use some of our graphics. They are also hoping to have cameras at the preparation areas, and have promised they won't interfere with the preparation of the athletes.

OBS was happy to trial a gate lighting system for slalom, but there was further discussions required concerning the celebration pontoons. Likely for slalom, but there were some problems for sprint to resolve.

#### **Paracanoe**

A detailed development plan for paracanoe which would include webinars and education modules was presented. It was emphasised that more regional competitions and activities were required and closer relationship with pararowing stakeholders was needed.

#### **Development Programme**

The work and monitoring of the development programme continued. The ICF was actually asking the beneficiary NFs to afford the transport costs. The reason was that the high transport costs rapidly diminish the budget for sport equipment affecting the entire programme. Cecilia thanked COPAC and ECA for supporting transportation costs with their budgets on specific cases.

#### **American Canoe Association**

There was an ongoing issue with ACA and governance of the sport in the USA. The situation had not improved with several recent resignations adding to the problem.

ACA was OK on recreational level, there was a big budget available. But not on competitive elite level.

Simon Toulson would meet USOC and LA2028 at Sportaccord in May 2019.

The ICF could not bypass the national federation to start working directly with athletes and coaches already identified within the country.

# Update on YOG 2022 Senegal

It was identified that problems with the venues due to water quality existed. Canoeing was not alone with issues. There was an alternative venue at the nearby ocean 1.5 hours drive from Dakar, but ICF would need to spend considerable money to make it work as no infrastructure is at the venue.

#### **Update on Tokyo 2020 preparations**

Updates were provided by Mr Narita, Jean-Michel Prono, John Edwards and Frank Garner on preparations for the Tokyo 2020 Olympic and Paralympic Games. The venues were on schedule and dates for the test events have been confirmed.

John Edwards urged all federations to get behind the new women's VL2 program, which has struggled for numbers but will make its Paralympic debut next year.

#### Juries for 2019 season

The Jury members were allocated by the ICF President.

#### **Miscellaneous**

The issue of Seif Patwa was discussed. However, it was made clear by the African representative on the BoD that Mr Patwa had tendered his resignation to CAC and all responsibilities were being separated to other members of CAC Board. The ICF was asked for assistance in helping CAC put its activities back on track, particularly in relation to Olympic Games qualification and development programme.

Some concerns over the role of the Athletes Committee at Technical meetings were raised. Whilst athlete representatives were valued additions to technical meetings they needed to respect the rules and structure of the meetings and decisions made. The ICF Secretary General would clarify the framework for athlete committee members with the Athlete Chair, Tim Lodge as soon as possible to avoid any misunderstandings or issues in the future.

The ICF would search for volunteers to hold the Chair of the ICF Ethics Committee that had been added recently to the ICF Statutes.
