As a Board member, I have worked with the CEO and Treasurer to monitor ICF's financial performance and contribute to systems improvements, including future financial plans. As part of the ICF working group I contributed significantly to the ICFs new policy on *Physical Harassment and Abuse in Sport*.

As Secretary General of Oceania, I have developed budgets and managed income received from the ICF to ensure it is distributed fairly and in the best interests of the Association. I have also ensured expenditure is kept within set limits.

As President and Chair of AC, I led the organisation from a negative net asset base (bankrupt), to a positive net asset base with an annual turnover of \$7.5 million. To manage the initial financial difficulties, I successfully managed a \$500,000 loan provided by the Australian Government and International Sport to keep the organisation solvent while I developed a future strategy with the Board. Within five years, AC was loan free and solvent. During this time I also championed change to improve culture by amalgamating the Australian Institute of Sport, High Performance function, to align with the wider sport and commenced the unification of AC and state based organisations under a single brand.

While still competing at an elite level in slalom canoeing, I was he National Coach and managed the national teams overseas, including manging budgets and resource issues on a daily basis.
