## **HOSTING ICF COMPETITIONS**

Thank you for your interest in hosting ICF event. On this page we summarise the key information of the ICF event-awarding process.

This renewed bidding process provides National Federations the opportunity to bid for hosting an ICF event at any point throughout the season. However, as the final decision of awarding events remains with the ICF Board of Directors, the main bidding timeline is adjusted to the Board meeting held every spring.

The first step of the event-bidding process is to complete the online form, which can only be accessed here:

## Intent form

Those who expressed their interest by filling in this form, will receive the template of the Hosting Agreement.

The second phase of the bid process is filling out the discipline-specific Bid Questionnaire that can be downloaded on the following link:

## Discipline Specific Questionnaires

The bidding documentation will be considered complete and eligible for evaluation only if all the questions of the Bid Questionnaire are answered, and the event budget is enclosed along with a signed Hosting Agreement. (The dates of the event are to be left blank.) The bidding documentation must be submitted to the <a href="mailto:events@canoeicf.sport">events@canoeicf.sport</a> email address and also to the respective <a href="mailto:committee chairperson">committee chairperson</a>.
The deadline of submission is February 3<sup>rd</sup>, 2025.

Please note an important adjustment to the bidding process: the removal of the upper limit for hosting fees. While the rules specify only the minimum required amount, prospective hosts now have the flexibility to propose an amount that aligns with their objectives.

The proposed fee will form part of the overall evaluation of the bid's quality before a final decision is made.

As of now, no events have been awarded for 2029 and beyond and they are open for bidding, according to the rules. For the 2027-2028 seasons the following competitions are available:
